Dear Member of WFMFC,

In 2005, the Society of the Weyburn Free Methodist Church chose to adopt the “Policy Board” model of board structure. It entails that the Society (as the membership of each Free Methodist Church is called) be led by a Board of Directors that is primarily responsible for policy governance matters (long-range planning, vision and purpose, empowering boundaries, and Lead Pastor support).

This year, up to five people may be elected to the Board. Marnell Cornish has faithfully served 2 consecutive terms and must step off the Board. Derrell Rodine and Ken Fedun are discerning whether or not to serve a second term. Currently there are 2 empty positions that we would love to fill. Here is a list of the current board members:

Your attendance at the Society meeting in January (exact date TBA), and participation in electing new leaders for our church is an essential opportunity to be active as a member of the church. *But you also have opportunity to be involved at the ‘front-end’ of the nominating process.* Here’s how:

Print a nomination sheet from [weyburnfmc.com/nominations](http://weyburnfmc.com/nominations) or pick one up from the Welcome Center. These sheets detail the qualifications that we are looking for in persons to serve in these capacities. Note that these include both character qualities and practical skills. Those sheets also provide opportunity for you to suggest names to the Nominating Committee. We have provided an appropriate number of lines on each sheet for you to nominate candidates.

When you suggest a name, we ask you to do three things:

1. Speak to the person you are nominating to affirm that they are aware of what’s involved, and are willing to be part of the process.
2. Seek endorsement of another member so that the nomination sheet is signed by two members of the church.
3. Return the sheet to the church office BY Monday, November 28th. The sheet may be

handed in; or, once signed by two members, it may be scanned and emailed to [info@weyburnfmc.com](mailto:info@weyburnfmc.com).

Your responses will be turned over to the Nominating Committee. They will set up interviews and prepare profiles of candidates. The nominees will be presented to the congregation in January.

Since the people who serve in these leadership positions **must be members**, a current list of active members is also available on the [weyburnfmc.com/nominations](http://weyburnfmc.com/nominations) page or at the Welcome Center to help guide your prayerful participation in this area of responsibility.
